Bidders are required to submit simultaneously two sealed envelopes, (i) One sealed envelope containing the technical Bid and labeled as "**Technical Proposal**" and, (ii) The Second sealed envelope containing Price Bid only and labeled as "**Price Bid**". Both in turn enclosed in one sealed envelope as per the provision included in ITB 21 of Bid Document. - Electronic bids must be submitted through <u>www.bolpatra.gov.np/egp</u> to the above office of *District Treasury Controller Office, Terhathum* on before *12:00* on *2074/10/20 (3rd Feb, 2018)*. Bids received after this deadline 7. will be rejected.
- The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2074/10/20 (3rd Feb, 2018) at the office of District Treasury Controller Office, Terhathum. Bids must be valid for 8. a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF format in case of e-bid, amounting to a minimum of **as specified above** which shall be valid for 30 days beyond the validity period i.e. 120 days of the bid after dateline for Bid submission last date. If the last date of Pre-Bid meeting/ purchasing /submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as

- 10. After the completion of evaluation of Technical Bids, which are substantially responsive bidders, will be invited to attend the opening of Price Bids. The date, time and location of opening of Price Bid shall be notified in writing and/or published in national daily.
