The Government of Nepal [GoN] **has allocated funds** towards the cost of **Construction of Kolenika Office Building, Rautahat (District Treasure Comptroller Office)** and intends to apply part of the funds to cover eligible payments under the Contract **for [DT/CO/RAUTAHAT/WORKS/NCB/01/077/078]**1. Bidding is open to all eligible as per Section V of bidding document.
2. **[District Treasure Comptroller Office, Rautahat]** invites sealed bids or electronic bids from eligible bidders for the construction of **Construction of Kolenika Office Building, Rautahat (District Treasure Comptroller Office)**2 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs 3,16,39,196.00]**
Minimum Work experience of similar size and nature: **[one project and value of each project [NRs 3,51,54,664.00]**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information at PPMO e-GP system www.bolpatra.gov.np/egp.
Bidder should download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at **Kolenika Rautahat]** at **Chaitra 1, 2077 (March 14, 5 2021)**.
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12 Pm on [2077- Chaitra 08]**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1 pm on 2077- Chaitra 08** at the office. Bids must be valid for a period of **[90 days]** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **[12,42,000.00]**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid
