- 4 Sealed bids must be submitted to the Financial Comptroller General Office, Anamnagar, and Kathmandu by hand before 12.00 hours on 2076/05/22. Bids received after this deadline will be rejected.
- 5 The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/05/22, 13.00 hours at the office of Anamnagar, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs 36000 which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.1201200001002524 District Treasury Controller Office, Babarmahal at Nepal Rastra Bank, Thapathali, Kathmandu and submit the receipt of the deposited amount of cash along with the Sealed Quotation..
